## USGA RULES OF GOVERN ALL PLAY WITH THE ADDITION OF THE FOLLOWING LOCAL RULES

OUT OF BOUNDS/LOST BALL: FOR GENERAL PLAY ONLY. The player may proceed under Local Rule E-5 rather than proceeding under stroke and distance. Local Rule E-5-The player to drop in a large area between the point where the ball is estimated to have come to rest or gone out of bounds and the edge of the fairway of the hole being played that is no nearer the hole. This option may not be used if a provisional ball has been played. The penalty is two strokes.

IMMOVABLE OBSTRUCTIONS: Players may take relief from immovable obstructions without penalty. Protective screens located at the teeing ground of Hole #8, separating Hole #10 from the 18th green and protecting Hole 15th green from the 16th tee box.

HOLE 11 DROP ZONE: A ball hit left of the green or right of the golf path and you have reasonable evidence (virtually certain) that the ball is in the hazard can be dropped in the drop zone right of the walkway. Drop up to 1 club length on a semi-circle no nearer to the hole under the penalty of 1 stroke.

HOLE 12 (Right Side) & 13(Left Side): The Penalty Area Red Stakes run around the hill between 12 & 13.

ETIQUETTE: Repair all divots and ball marks and rake all bunkers.

CARTS: Please keep golf carts on paths around tees, greens and all par 3's. The 90\* rule is in effect unless otherwise indicated.

PACE OF PLAY: The expected pace of play is 4 hours. For the benefit of all players, play ready golf. If you lose your position on the course, you may be asked to move forward.
